AGREEMENT FOR FULL RELEASE, COVENANT NOT TO SUE, AND ACKNOWLEDGMENT

For and consideration of the mutual promises between parties to this agreement, the receipt and sufficiency of which are hereby acknowledged, (YOUR NAME), _____ (hereinafter referred to as "shooter") Southern Shooting Center, LLC (hereinafter referred to as "the Range"), and South Louisiana International Defense Pistol Association (hereinafter referred to a "SLIDPA"), agree as follows:

1. Shooter acknowledges that shooting has inherent risks, hazards, and dangers that cannot be eliminated. Shooter understands these risks, hazards and dangers included without limitation:
 - a. The risk of handling firearms and being near others that have firearms in their possession;
 - b. The risk of injury from ammunition and shots from other guns, range equipment, including but not limited to ricochets, crossfire, and bullet splatter;
 - c. The risk of using the premises, facility, equipment and/or personnel.
 - d. The risk of injury from riding on an all-terrain vehicle (ATV) or any vehicle used off the paved road;
 - e. The risk of injury from the use of but not limited to: range equipment, targets, target systems, misfired weapons and/or misfired ammo.
 - f. The risk of walking in rugged area, unlevelled ground, encounters with wildlife, animals and insects;
 Shooter understands the risks, hazards, and dangers as described above and have had the opportunity to discuss them with the Range and/or SLIDPA. Shooter understands that these activities may require good physical conditioning and a degree of skill and knowledge. Shooter believes he/she have the good physical conditioning and the degree of skill and knowledge necessary for him/her to engage in these activities safely. Shooter understands that he/she has responsibilities to assume and bear the costs of all risks that may be created, directly or indirectly, by any such action.
2. Shooter is voluntarily using the services of the Range with full knowledge of inherent risk, hazards, injury, paralysis or death.
3. Shooter expressly agrees and promises to accept and assume all risks existing in SLIDPA activities in which Shooter participates. Shooter participation in these activities is purely voluntary, and Shooter elects to participate in spite of the risks.
4. Shooter for himself/herself, his/her heirs, successors, executors, and subrogates, hereby, knowingly and intentionally waive and release, indemnify and hold harmless the Range, their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or in any way connected with shooter participation in this activity including, but not limited to, negligence of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to shooter or shooter's property as a result of shooter engaging in these activities or the use of these services, animals or equipment, whether such damage, loss, injury, paralysis or death results from negligence of the Range or from some other cause. Shooter, for himself/herself, his/her heirs, successors, executors and subrogates further agree not to sue the Range as a result of any injury, paralysis, or death suffered in connection with shooter's use and participation in the activities of SLIDPA.
5. Shooter hereby voluntarily releases, forever discharges, and agree to indemnify and hold harmless SLIDPA from any and all claims, demands, or causes of action, which are in any way connected with shooter's participation in SLIDPA activities or shooter's use of SLIPDA's equipment, including any such claims which allege negligent acts or omissions of SLIDPA.
6. Should SLIDPA, or anyone acting on its behalf, be required to incur attorney's fees and other costs to enforce this Agreement, shooter agrees to indemnify and hold them harmless for all such fees and costs.
7. Shooter certifies that I have adequate insurance to cover any injury or damage he/she may cause to suffer while participating, or else bear the costs of such injury himself/herself.
8. A Photocopy of this release shall be a valid as the original.
9. By signing this Agreement, Shooter acknowledges that if anyone is hurt or property is damaged during his/her participation in these activities, he/she may be found by a court of law to have waived his/her right to maintain a lawsuit against the Range and/or SLIDPA on the basis of any claim from which he/she has released to the Range and/or SLIDPA herein. Shooter has had sufficient opportunity to read this entire Agreement. Shooter has read it and understood it, and agrees to be bound by its terms.
